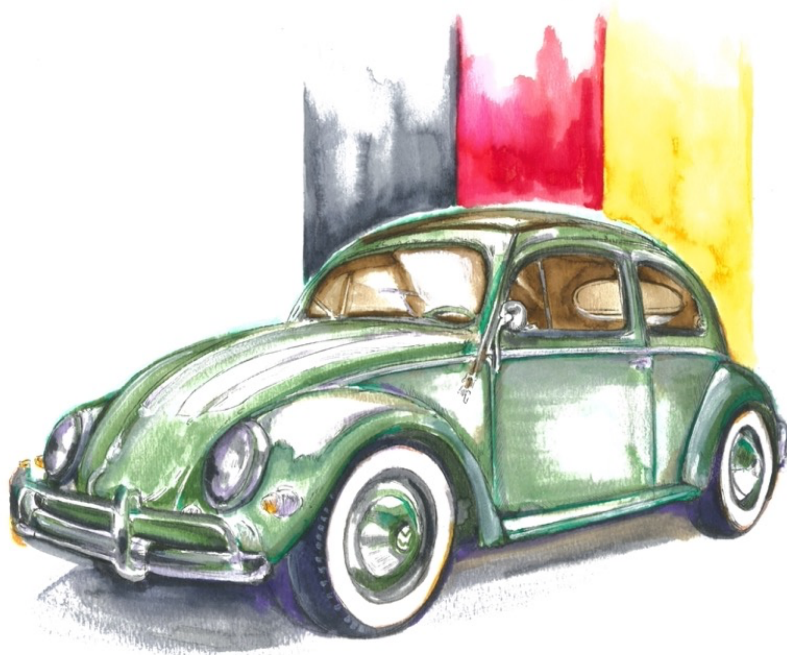




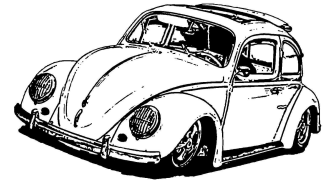

### TIMELINE

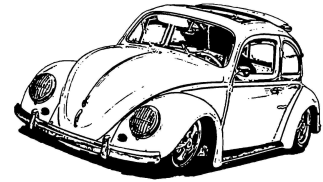
6:00 am	Car show staff shows up

10:00 am	Judging begins

2:00 pm	Show Closes

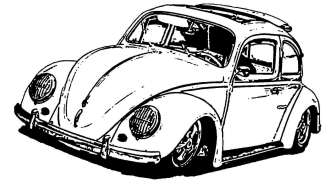

**Questions the Day of the Show:** From 6:30 am to 7:30 am there will be a Guide available to conduct you to your assigned location on the show's 'Main Street'. This person will be wearing a green vest to make this person easy to find. Make sure gate staff know you are a sponsor; you will be guided to jump the line to your assigned spot. Bring door prize donations to the club HQ canopy.

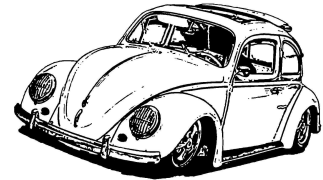
**Your Show Cars:** Eligible voters will be alerted to the fact that cars in your display are also competing for a trophy. Make sure you go to the registration canopy and get a windshield card for each of your display cars and a ballot packet for each car. That way your car(s) are in the running for a trophy, and you or a proxy can walk around and vote for your favorites! Ballots are due at the HQ canopy by noon.

**Canopies:** The wind comes up in the afternoon. If your push up canopy seems unstable, be proactive, don't wait for us to ask you to take it down. Blowing canopies have damaged expensive show cars in past VWOTG shows! Many of the California shows just don't allow them at all due to on-going problems. The best option is to have stakes, weights, sandbags etc. to weigh all four legs of your canopy down. You are liable for any damage your canopy causes. Canopies enhance everyone's experience at the show, and we are hoping to continue to allow them at future VWOTG car shows!

**Pro Tip:** The website is noted in the header. There is a Car Show section on that site that will answer many of your questions and give you a better idea of what the show will be like in this new location. Pay particular attention to the FAQs.
